#### ORDER:-

In the G.O. first read above, the Government have accorded administrative and financial sanction for Rs.8,00,00,000/- (Rupees Eight crore only) for setting up a new Elephant camp at Sadivayal in Coimbatore District with necessary facilities for maintenance of elephants.

2. In the Government letter second read above, the Government have directed the Principal Chief Conservator of Forests and Chief Wildlife Warden to incur Rs.3.70 crore available in the B.E.2024-25.

3. The Principal Chief Conservator of Forests and Chief Wildlife Warden in his letter third read above has requested to release the balance amount of Rs.301.50 lakhs for setting up a new Elephant camp at Sadivayal in Coimbatore District with necessary facilities for maintenance of elephants.

4. The Government after careful examination accord sanction for Rs. 1,82,82,000/- (Rupees one crore eighty two lakh and eighty two thousand only) for setting up a new Elephant camp at Sadivayal in Coimbatore District with necessary facilities for maintenance of elephants.

5. The Principal Chief Conservator of Forests and Chief Wildlife Warden has authorized to incur the amount available in Budget Estimate for the year 2025-2026 under the following head of account:-
